**ABSTRACT**

ELECTIONS - Rural Local Bodies - Indirect Elections 2013 - Theni District, K.Mayiladumparai Panchayat Union Council - Chairman and Vice-Chairman Elections - Fixed on 18.3.2013 - Conduct of election meeting in the Council Hall of District Panchayat Office, Theni District - Instead of K.Mayiladumparai Panchayat Union Office - Orders issued.

**ORDER:**

The Tamil Nadu State Election Commission in the reference <sup>1st</sup> read above, has inter-alia fixed 18.3.2013 as the date for convening the meeting for the conduct of indirect elections for the posts of Chairman and Vice-Chairman of K.Mayiladumparai Panchayat Union.

Whereas, the District Election Officer / District Collector, Theni District in the reference <sup>2nd</sup> read above, has sent proposal to the Commission that the election meeting for the conduct of Indirect Election to the offices of Chairman and Vice-Chairman of K.Mayiladumparai Panchayat Union may be conducted at "**Council hall of District Panchayat Office, Theni District**" instead of Panchayat Union Office of K.Mayiladumparai Panchayat Union.

Whereas, rule 71 and rule 91 (3) of the Tamil Nadu Panchayats (Elections) Rules, 1995 inter-alia prescribe that the meeting for the indirect elections shall be held in the offices of the respective panchayats.

Whereas, it has become expedient to issue suitable orders by the Tamil Nadu State Election Commission for the removal of certain difficulties as expressed by the District Election Officer/District Collector, Theni District and to ensure the smooth conduct of elections in a free and fair manner.



Whereas, rule 143 of the Tamil Nadu Panchayats (Elections) Rules, 1995 empowers the State Election Commission to issue general or special directions which is necessary for holding the elections and the rule provisions are as follows:

"143. Removal of difficulties if any, by State Election Commission.- (1) The State Election Commission may issue such general or special directions as may in its opinion be necessary, for the purpose of giving due effect to these Rules, or holding any election under the Act.

(2) If any difficulty arises in giving effect to the provisions of these Rules, or in holding any election, the State Election Commission as occasion may require, may, by order, do anything which appears to it necessary for the purpose of removing the difficulty."

Now, therefore, the Tamil Nadu State Election Commission, in pursuance of rule 143 of Tamil Nadu panchayats (Elections) Rules, 1995 hereby orders that the meeting for the indirect elections fixed on 18.3.2013 for the offices of Chairman and Vice-Chairman of K.Mayiladumparai Panchayat Union Council, Theni District shall be convened at the **"Council hall of the District Panchayat Office, Theni District"** as recommended by the District Election Officer/District Collector, Theni District.

The District Election Officer/District Collector, Theni District shall ensure that all elaborate arrangements such as adequate bandhobust, videography are made and the elections are conducted and completed smoothly in a free and fair manner.
