#### **ORDER:**

WHEREAS, the Tamil Nadu State Election Commission *inter-alia* notified casual election to Ward No.2 of Chetpet Panchayat Union Council, Thiruvannamalai District scheduled to be held on 18.9.2014 in the Notification first read above;

WHEREAS, a representation received from the State Secretary, Communist Party of India (Marxist) stated that the nomination of one Thiru V. Venkatesan, Candidate of Communist Party of India (Marxist) was rejected by the Assistant Returning Officer without valid reasons;

WHEREAS, based on the above said petition, the Tamil Nadu State Election Commission called for report from the District Election Officer/District Collector, Thiruvannamalai;

WHEREAS, the District Election Officer/District Collector, Thiruvannamalai has sent his detailed and specific report in the reference second read above and reported that the Assistant Returning Officer of the said election has initially published a list of validly nominated candidates in Form 6 on 5.9.2014 and subsequently he has published another list of validly nominated candidates in Form 6 on the same day; WHEREAS, sub-rule (5) of rule 29 of the Tamil Nadu Panchayats (Elections) Rules, 1995, provides that the Returning Officer shall not reject any nomination paper on the ground of any defect which is not of a substantial character; and

WHEREAS, thus an unforeseen circumstance has arisen which has led to difficulty in conducting the casual election to Ward No.2 of Chetpet Panchayat Union scheduled to be held on 18.9.2014 since the list of contesting candidates (Form 9) is not able to be published.

NOW, THEREFORE, the Tamil Nadu State Election Commission, in pursuance of rule 143 of the Tamil Nadu Panchayats (Elections) Rules, 1995, hereby orders that the casual election to Ward No.2 of Chetpet Panchayat Union, Thiruvannamalai District, scheduled to be held on 18.9.2014 is hereby cancelled and also orders that all the election proceedings of the Returning Officer/Assistant Returning Officer for the said office notified in the Statutory Orders first read above in pursuance of rule 25 to 29 of the Tamil Nadu Panchayats (Elections) Rules, 1995 so far as it relates to the above office be held to be null and void.
