### NOTIFICATION

In exercise of the powers conferred under rule 9 of the Tamil Nadu Town Panchayats, Third Grade Municipalities, Municipalities and Corporations (Elections) Rules, 2006 and in supersession of the Notification No. 264 under No. VI(2)/420(e)/2011 published at Page I of Part VI – Section 2 of the Tamil Nadu Government Gazette Extra-ordinary, dated the 12<sup>th</sup> August, 2011, the State Election Commission hereby directs the District Election Officers except in the District of Chennai to appoint within their respective jurisdictions the Executive Officer of the Town Panchayat or Third Grade Municipality or the Commissioner of Municipality or City Municipal Corporation respectively or any other officer of the Government as Returning Officer for the conduct of election to the Town Panchayat or Third Grade Municipality or Municipality or City Municipal Corporation, as the case may be, under the said Rules.
