#### ORDER:

In exercise of the powers conferred by sub-rule (4) of rule 24 of the Tamil Nadu Panchayats (Elections) Rules, 1995 and sub-rule (3) of rule 22 of the Tamil Nadu Town Panchayats, Third Grade Municipalities, Municipalities and Corporations (Elections) Rules, 2006 and in supersession of the Statutory Order read above, the Tamil Nadu State Election Commission hereby directs that:
