ORDER:

WHEREAS, the Tamil Nadu State Election Commission appointed the District Collectors concerned excepting the Collector of Chennai as the District Election Officers for their respective Districts for performing the functions specified in sub-rule (2) of rule 6 of the Tamil Nadu Panchayats (Elections) Rules, 1995 in connection with the conduct of elections to Panchayats vide Tamil Nadu State Election Commission's Statutory Order No.2/2017/TNSEC/PE-1, Dated 03.03.2017 and the same has been published in the Tamil Nadu Government Gazette Extraordinary issue No. 58, Part VI--Section 2, Dated 6.3.2017 vide notification No. VI(2)/27(a-2)/2017;

WHEREAS, the Hon'ble High Court of Madras has recorded in the Contempt Petition No. 1697/2017 and CMP No. 16875/2017 in W.A. No. 1268/2017 Dated 07.01.2019 that the necessary notification for conducting local body elections will be issued by the end of May 2019 (31.05.2019);

AND WHEREAS, as recorded in the Contempt Petition No. 1697/2017 and CMP No. 16875/2017 in WA No. 1268/2017 by the Hon'ble High Court of Madras, the election notification has to be issued by the Tamil Nadu State Election Commission in time and to expedite the process of election immediately;

NOW, THEREFORE, in exercise of the powers conferred by sub-rule (2) of the rule 6 of the Tamil Nadu Panchayats (Elections) Rules, 1995 and in supersession of the notification No. VI(2)/27(a-2)/2017 has published in Part VI--Section 2 of the Tamil Nadu Government Gazette Extraordinary No. 58, dated 6.3.2017 at Page No.1-2, the Tamil Nadu State Election Commission hereby appoints the District Collectors concerned excepting the Collector of Chennai as the District Election Officers for their respective Districts. Subject to the superintendence, direction and control of the Tamil Nadu State Election Commission, they shall co-ordinate and supervise the preparation and publication of electoral rolls of Panchayats and the conduct of elections to the offices of members of Village Panchayats, Panchayat Union Councils and the District Panchayats, Presidents and Vice-Presidents of Village Panchayats, Chairpersons and Vice-Chairpersons of Panchayat Union Councils and District Panchayats in their respective Districts. They shall also perform such other functions as are entrusted to them by the Tamil Nadu State Election Commission, from time to time, in connection with the conduct of Elections to Panchayats.
