## NOTIFICATION

WHEREAS, in the Tamil Nadu Municipal Laws (Fifth Amendment) Ordinance, 2019 (Tamil Nadu Ordinance 8 of 2019), the Government have issued amendment to the Tamil Nadu District Municipalities Act, 1920, Chennai City Municipal Corporation Act, 1919, Madurai City Municipal Corporation Act, 1971, Coimbatore City Municipal Corporation Act, 1981 relating to change in the manner of election of Mayor of Corporations, Chairman of the Municipalities and Town Panchayats from Direct to Indirect method.

Now, THEREFORE, in exercise of the powers conferred under clause 11 of the Tamil Nadu Local Bodies Election Symbols (Reservation and Allotment) Order, 2019, the following amendments are issued to the said Order published vide Notification No.362, at pages 1 to 16 of Part VI Section 2 of the Tamil Nadu Government Gazette Extraordinary dated 13.09.2019:-

#### **AMENDMENTS**

In the said Order of English version:-

- 1. in paragraph 7(1)A, the expressions in the third and fourth lines "or for the office of the Chairman / Mayor as the case may be, in any urban Local Body" shall be omitted.
- 2. in para 7(1)B, the expressions in the fourth and fifth lines "or for the office of the Chairman / Mayor as the case may be, in any urban Local Body" shall be omitted.
- 3. in FORM A, in "To" address entry, the expressions "/ Mayor / Chairman" shall be omitted.
- 4. in FORM B, in "To" address entry, the expressions "/ Mayor / Chairman" shall be omitted.
- 5. in FORM C, the expressions in the second line "/ Chairman / Mayor" shall be omitted.

In the said Order of Tamil version :-

- 9. படிவம் B-ல் பெறுநர் பகுதியில் உள்ள **''தலைவர்** / **மேயர்''** என்ற சொற்றொடர்கள் நீக்கப்பட வேண்டும்.
- 10. படிவம் C-ல் மூன்றாவது வரியில் உள்ள ''**தலைவர்** / **மேயர்**'' என்ற சொற்றொடர்கள் நீக்கப்பட வேண்டும்.
