NOTIFICATION

WHEREAS, in the Tamil Nadu Municipal Laws (Fifth Amendment) Ordinance, 2019 (Tamil Nadu Ordinance 8 of 2019), the Government have issued amendment to the Tamil Nadu District Municipalities Act, 1920, Chennai City Municipal Corporation Act, 1919, Madurai City Municipal Corporation Act, 1971, Coimbatore City Municipal Corporation Act, 1981 relating to change in the manner of election of Mayor of Corporations, Chairman of the Municipalities and Town Panchayats from Direct to Indirect method.


Now, THEREFORE, in exercise of the powers conferred under paragraph 3 of the Tamil Nadu Local Bodies Election Symbols (Reservation and Allotment) Order, 2019, the following amendments are issued to S.O.No.15/2019/TNSEC/ME1 dated 24.9.2019 published vide Notification No.370 at page 1 of Part VI Section 2 of the Tamil Nadu Government Gazette Extraordinary dated 27.09.2019:-
