#### ORDER:

WHEREAS it has been reported by the District Election Officer/District Collector, Thiruvarur that for the post of Village Panchayat Ward Member of Ward No.1 of Serukudi Village Panchayat, Kodavasal Panchayat Union only two candidates were in the contest as follows:

Sl. No.	Name of the candidate	Symbol allotted
1.	Premavathi	Key (திறவுகோல்)
2.	Maheswari	Comb (சீப்பு)

WHEREAS, between the above said candidates one Thirumathi.R.Premavathi, W/o. Rajendran expired on 21.12.2019 i.e. after the publication of final list of contesting candidates in Form 9 and now thereby having only one candidate in the contest.

WHEREAS it is not possible to complete the election to the said Ward No.1 of Serukudi Village Panchayat Ward Member before 4.1.2020 as notified by the Tamil Nadu State Election Commission; and


WHEREAS a difficulty has thus arisen in conducting the election of the Ward Member of Ward No.1 of Serukudi Village Panchayat on 30.12.2019 with only one contesting candidate in the fray and it is therefore considered expedient to adjourn the election of Village Panchayat Ward Member of Ward No.1, Serukudi Village Panchayat, Kodavasal Panchayat Union.

NOW, THEREFORE, the Tamil Nadu State Election Commission, in pursuance of Article 243-K of the Constitution of India and Rule 143 of Tamil Nadu panchayats (Elections) Rules, 1995 hereby orders that the poll fixed on 30.12.2019 for the election of Village Panchayat Ward Member of Ward No.1 of Serukudi Village Panchayat, Kodavasal Panchayat Union be adjourned to a later date for fresh election.

This order will not affect the poll fixed for other elections namely election of the President of Serukudi Village Panchayat, the members of relevant ward of Kodavasal Panchayat Union and the member of the relevant ward of the Thiruvarur District Panchayat.
