NOTIFICATION

WHEREAS, the Government have bifurcated the Villupuram District into Villupuram and Kallakurichi Districts; the Tirunelveli District into Tirunelveli and Tenkasi Districts; the Kancheepuram District into Kancheepuram and Chengalpattu Districts and trifurcated the Vellore District into Vellore, Tirupathur and Ranipet Districts vide G.O.(Ms).No(s).425, 427, 429, 431, Revenue and Disaster Management Department, Revenue Administration Wing,[RA 1(1)]Section, dated 12.11.2019 respectively;

WHEREAS, consequent on the bifurcation of Villupuram, Tirunelveli and Kancheepuram and trifurcation of Vellore district, the Government have issued orders of constituting the District Panchayats for the newly constituted districts vide G.O.(Ms)No.21, Rural Development and Panchayat Raj (PR1) Department, dated 27.01.2020; and G.O.(Ms)No(s).32, 33, 34, Rural Development and Panchayat Raj (PR1) Department, dated 15.02.2020;

NOW, THEREFORE, in exercise of the powers conferred by rule 8 and 10 of the Tamil Nadu Panchayats (Elections) Rules, 1995 and as per S.O.No.9/2019/TNSEC/PE1, dated 28.08.2019 published, *inter-alia*, in the Tamil Nadu Government Gazette Extraordinary Issue No.350, dated 03.09.2019 at page No.1 of Part VI-Section 2 vide Notification No.VI(2)/82(a-1)/2019, the Tamil Nadu State Election Commission hereby authorises the District Election Officers of newly constituted districts viz. Kallakurichi, Tenkasi, Chengalpattu, Tirupathur and Ranipet Districts to make appointment of Returning Officers and Assistant Returning Officers for the conduct of election of Ward Members of the District Panchayats, Panchayat Union Councils and Village Panchayats and also for the conduct of the election of Presidents of Village Panchayats within their respective jurisdiction in connection with the conduct of Elections to Panchayats.
