NOTIFICATION

WHEREAS, the Government have bifurcated the Villupuram District into Villupuram and Kallakurichi Districts; the Tirunelveli District into Tirunelveli and Tenkasi Districts; the Kancheepuram District into Kancheepuram and Chengalpattu Districts and trifurcated the Vellore Districts into Vellore, Tirupathur and Ranipet Districts vide G.O (Ms).No(s). 425, 429, 431, Revenue and Disaster Management Department, Revenue Administration Wing,[RA1(1)] Section, dated 12.11.2019 respectively;

NOW, THEREFORE, in exercise of the powers conferred by rule 9 of the Tamil Nadu Town Panchayats, Municipalities and Corporations (Elections) Rules, 2006 and as per S.O.No.10/2019/TNSEC/ME1, dated 28.08.2019 published, inter-alia, in the Tamil Nadu Government Gazette Extraordinary Issue No.350, dated 03.09.2019 at page No.1 of part VI - Section 2 vide Notification No.VI(2)/82(a-2)/ 2019 , the Tamil Nadu State Election Commission hereby directs the District Election Officers of newly constituted districts viz. Kallakurichi, Tenkasi, Chengalpattu, Tirupathur and Ranipet Districts to appoint within their respective jurisdictions the Executive Officers of the Town Panchayat or the Commissioner of Municipality respectively or any other officer of the Government as Returning Officer for the conduct of Election to the Town Panchayat or Municipality as the case may be, under the said Rules.
