In exercise of the powers conferred under rule 15 of the Tamil Nadu Urban Local Bodies Rules, 2023 and in supersession of the Notification No.500 under No.VI (2)/109(a-12)/2021 published at page 4 of Part VI-Section 2 of the Tamil Nadu Government Gazette Extraordinary, dated the 23<sup>rd</sup> October, 2021, the Tamil Nadu State Election Commission hereby directs the District Election Officers except in the District of Chennai to appoint within their respective jurisdictions the Executive Officer of the Town Panchayat or the Commissioner of the Municipal Council or Municipal Corporation respectively or any other officer of the Government as Returning Officer for the conduct of election to the Town Panchayat or Municipal Council or Municipal Corporation, as the case may be, under the said Rules.
